The Models are managed by AE Wealth Management Investment Committee. The Models are expected to primarily consist of mutual funds and exchange traded funds (ETFs). The Models are generally comprised of funds that invest in U.S. Large Cap, U.S. Mid Cap, U.S. Small Cap, International Large Cap, International Small Cap, Emerging Markets (All capitalizations), U.S. Aggregate Fixed Income, U.S. High Yield and U.S. TIPS. The Models generally consist of between 5 and 22 mutual funds and exchange traded funds, with a typical weighting for each position being between 0%-35% of the total portfolio. Each underlying fund in the Models has a designated minimum investment specified in the prospectus of that fund. Since the Models invest in mutual funds and ETFs, an investor will indirectly bear fees and other expenses charged by the underlying funds in which the Models invest in addition to direct management and custody fees and other expenses applicable to the Models. The Models are expected to consist of institutional share class equity mutual funds. The underlying mutual funds in the Models are limited to those with no sales loads or 12(b)-1 fees.
